Privacy Statement

General

NGS Power, LLC. dba Norpro respects the privacy of every individual who visits the NGS Power, LLC. dba Norpro Web Site ("Site") or provides information to us over the Internet. This Privacy Policy outlines what information NGS Power, LLC. dba Norpro ("Norpro") will collect and how we will treat the information.

When you visit the Site, we will not collect any personally identifiable information about you (such as your name, address, telephone number or e-mail address) unless you provide it to us voluntarily. Portions of the Site may request visitors to submit names, e-mail addresses and other personally identifiable information in connection with registering for product information. By submitting personally identifiable information, you agree, without limitation or qualification, to this information being used exclusively by Norpro for business purposes. Norpro collects this information to evaluate the use of and to make improvements to the Site.

We will not send unsolicited email to our customers or visitors of the Site. We will only use e-mail to respond to e-mail messages from visitors or engage in other communication which the visitor has expressly requested.
